Because of reporting lag, their most recent data is generally 2-3 years old. In most cases, state-level abortion facts are more current than the numbers reported by AGI or the CDC.

STATE-LEVEL DATA

Total Abortions (2015): 5,899

The Alabama Center for Health Statistics reports that 5,899 abortions took place in Alabama during 2015.

Total Abortions (2014): 8,080

The Alabama Center for Health Statistics reports that 8,080 abortions took place in Alabama during 2014.

Total Abortions (2013): 8,485

The Centers for Disease Control (CDC) reports that 8,485 abortions took place in Alabama during 2013. The table below compares Alabama abortion totals by year.

SOCIAL MEDIA GRAPHICS:

In 2013, 12.7% of pregnancies in Alabama ended in abortion. This number does not take into account miscarriages. It was arrived at by dividing the state abortion ratio by the sum of the abortion ratio plus 1,000. The abortion ratio is the number of abortions that occurred per 1,000 lives births. The table below compares Alabama abortion percentages by year.

Out-of-State Abortion Percentage (2013): 17.5%

The Centers for Disease Control (CDC) reports that 17.5% of the abortions that took place in Alabama were performed on out-of-state residents.

*U.S. averages are limited to reporting districts.

GUTTMACHER DATA

Total Abortions (2014): 8,020

The Guttmacher Institute reports that 8,020 abortions took place in Alabama during 2014. In 2011, there were 9,550 abortions reported—compared with 11,270 in 2008 and 11,340 in 2005.

Abortion Rate* (2014): 8.3

The Guttmacher Institute reports that the 2014 abortion rate for Alabama was 8.3. In 2011, the abortion rate in Alabama was 10. It was 12 in 2008, 11.9 in 2005, and 14.3 in 2000. The 2014 abortion rate across the entire United States was 14.6.

*The abortion rate is the number of abortions per 1,000 women aged 15-44 years.

Percentage of Pregnancies Ending in Abortion (2011): 12%

In 2011, 81,700 women in Alabama became pregnant. 73% of these pregnancies resulted in live births and 12% in induced abortions. The remaining pregnancies ended in miscarriage.

Percentage of All U.S. Abortions (2014): 0.9%

In 2014, 0.9% of all U.S. abortions occurred in Alabama.

Facilities That Perform Abortions (2011): 8

In 2011, the Guttmacher Institute reports that there were 8 abortion providers in Alabama. There were 8 providers in 2008, 13 providers in 2005, and 14 providers in 2000.

State Abortion Restrictions (2016):

- A woman must receive state-directed counseling about abortion and then wait 48 hours before the abortion takes place.
- Health plans offered in the state's health exchange can only cover abortion in cases of life endangerment, rape or incest.
- The use of telemedicine for the performance of medication abortion is prohibited.
- The parent of a minor must consent before an abortion can take place.
- Public funding is available for abortion only in cases of life endangerment, rape or incest.
- A woman must undergo an ultrasound before obtaining an abortion and must be given the option to view the image.
- An abortion cannot be performed at or after 20 weeks postfertilization (22 weeks after the woman's last menstrual period) unless the woman's life is endangered or her physical health is severely compromised.

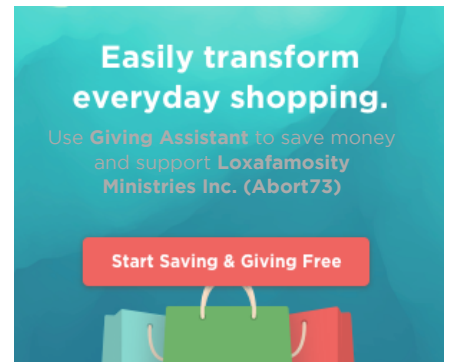
